Answer: According to Section 43 of the Right to Information Act No.12 of 2016,

"information" includes any material which is recorded in , in any form including records, documents, memos, emails, opinions, advices, press releases, circulars, orders, log books, contracts, reports, papers, samples, models, correspondence, memorandum, draft legislation, book, plan, map, drawing, diagram, pictorial or graphic work, photograph, film, microfilm, sound recording, video tape, machine readable record, computer records and other documentary material, regardless of its physical form or character and any copy thereof:

Therefore, available information can only be requested under the provisions of Right to Information Act. But, instead of requesting any particular available information, you have raised a question which is not falling under the provisions of Right to Information Act.

Furthermore, recruitment procedures within the university system are conducted in accordance with the provisions of the Establishments Code of the University Grants Commission and Higher Educational Institutions/Institutes, as well as the relevant Circulars on Scheme of the Recruitment. In addition, the salaries of all employees in the university system are determined and paid in accordance with the salary scales approved by the Department of Management Services.
